### **Types of Membership**

### **Eligibility for Ordinary Membership**

---

Any person, partnership, or company, carrying on a business which operates a charter vessel, or vessels, registered under the provisions of the Western Australian Marine Act, may apply for one ordinary membership of the Association.

**Annual Fee is for the period July to June**

---

### **Eligibility for Associate Membership**

---

Any person being in a business that is able to provide support to the Western Australian charter boat industry, may apply for associate membership of the Association.

**Annual Fee is for the period July to June**



## **Membership Application Process**

This application will be reviewed by the full MTWA Board once all details are completed and full payment is received.

All applicants will be notified of the status of their application by the office of the Association within two weeks of receipt of completed application. All successful applicants will be granted probationary status for 12 months and, provided that there are no breaches of the Code of Conduct, this will be automatically converted to full Associate or Ordinary Membership upon renewal of membership in the following year. Probationary members are entitled to vote at the AGM, nominate for Committee Membership and may take advantage of all membership benefits.

The MTWA reserves the right to deny access to, or remove from membership any individual not found to be acting within the Code of Conduct or in the best interests of the Association.

All members must support/attend at least one MTWA activity/event per calendar year to retain their membership. Members who are Not located in Perth are exempt from attending.
